The Region I Field Office, NRC Office of Investigations (OI), initiated an investigation (Case No. 1-2015-003) on October 30, 2014, to determine whether two workers at the Susquehanna Steam Electric Station deliberately violated high radiation area (HRA) access requirements. Based upon documentary and testimonial evidence developed during the OI investigation, there was insufficient evidence developed for the NRC to substantiate that the workers deliberately violated HRA access requirements.
