The petitioner discusses various events at Palisades which have resulted in equipment failures such as breaking of the primary coolant pump impeller vanes, Control Rod Drive Mechanisms (CRDMs) leaks, leaks from Safety Injection Refueling Water Tank etc. His immediate request is to prevent Palisades restart prior to removal of the broken vane. He is also requesting replacement of all CRDMs before plant startup. (The licensee has already taken this action by replacing all CRDMs units).

The petition contends that the installed flood-protection measures and systems and barriers at CNS will not adequately protect the reactor from a full-meltdown scenario; the licensee's station blackout procedures are not sufficient to meet a challenging extended loss of off-site power caused by flooding, natural disasters, or terrorist attacks; the licensee failed to notify the NRC of the declaration of an unusual event within a 1 hour period.

Issues/Actions Requested:

The joint petitioners requested that the FitzPatrick operating license be immediately suspended because they believe the operator relies on non-conservative and wrong assumptions for the analysis of the capability of FitzPatrick's pre-existing ductwork containment vent system. The joint petitioners requested that the suspension of the operating license be in effect pending final resolution of a public challenge to the adequacy of the pre-existing vent line in light of the Fukushima Dai-ichi nuclear accident. The joint petitioners did not seek or request that FitzPatrick operators now install the Direct Torus Vent System as it is demonstrated to have experienced multiple failures to mitigate the severe nuclear accidents at Fukushima Dai-ichi.
