Subject: Non-Payment of Fees

Discussion: Blake Welling, Branch Chief CIRDA received an e-mail from the CFO's office regarding EVRAZ's non-payment of fees and requested assistance in contacting them. Welling assigned the action to Steven Courtemanche. Internet story of November 11, 2014, indicated that Commercial Development Company, Inc., in association with three other companies, planned to buy the site, remediate it, and redevelop it. (11:21 6/3/15) I attempted to contact the RSO, Clint Snyder at 302-897-4904. The phone message indicated that the recipient was unavailable and I left a call-back number. (11:40) I was able to contact David Kline. Mr. Kline indicated that he transferred to another division of EVRAZ in November of 2014, that the gauge was being stored off-site, and that the gauge would be transferred to another EVRAZ facility in Canada. I requested the following information: (1) When was the gauge removed from the site? (2) Who removed the gauge from the site and what company was the person affiliated? (3) Where is the gauge currently stored? (Street address to allow for a site visit.) (4) Does EVRAZ have an NRC or Agreement State license for the location the gauge is being stored? (Provide the information about the license.) and (5) Describe the means by which EVRAZ is preventing unauthorized access. I informed Mr. Kline that a representative from the CFO's office may contact him and that EVRAZ should start the process for termination of the EVRAZ NRC license. (12:22) Mr. Kline determined that the gauge was removed from the site on 1/8/2015. The gauge was removed from the site by NSSI of Houston, TX. (I determined that NSSI had Texas LN L-02991.) The gauge is being stored at NSSI's facility in Houston, TX. Mr. Kline stated that he would have a representative of NSSI contact me regarding my other questions.

Action Required: Document for possible termination of the license.
