BACKGROUND

By letter dated June 29 2015, (Agencywide Documents Access and Management System (ADAMS) Accession Number ML115181A078 and ML15181A079), Southern Nuclear Company, Inc. (SNC) and South Carolina Electric and Gas Company (SCE&G), submitted License Amendment Request (LAR) for Vogtle Electric Generating Plant (VEGP) Units 3 and 4 and Virgil C. Summer Nuclear Station Units 2 and 3. The proposed amendment would allow the use of AWS D1.1 -2000 for structural welds. These units are Westinghouse AP1000 reactors. VEGP and VCSNS Updated Final safety Analysis Report (UFSAR) Sections 3.7 and 3.8 incorporate by reference AP1000 Design Control Document (DCD) (Revision 19) Sections 3.7 and 3.8 and address applicable combined licenses action items and site specific features.

In the License Amendment Requests (LARs) the licensees mentioned a finite element analysis (FEA) for out-of-plane loading on the fillet weld was performed to compare the differences between linear welds and concentrically loaded circular group. The FEA is used for benchmark to cruciform-shaped tests from Gomez et al. report, to confirm behavior of the circular weld group.

The purpose of this audit is to verify that the results of the FEA benchmark analysis and additional calculation notes confirmed that linear out-of plane behavior is similar to circular weld out-of-plane behavior.

REGULATORY AUDIT BASES

For Vogtle and Summer, UFSAR Section 3.8, the acceptance criteria associated with the relevant requirements of the Commission regulations (General Design Criterion (GDC) 1, GDC 2, and GDC 4,, of Appendix A to 10 CFR Part 50; 10 CFR 50.55(a) and Appendix B, to 10 CFR Part 50) are given in Section 3.8.3 and 3.8.4 of NUREG-0800.

REGULATORY AUDIT SCOPE OR METHODOLOGY

Details regarding the FEA analysis and the weld design of coupler will be reviewed by the staff and will be used to support the safety findings of the LARs. Calculations supporting the licensee's analysis will be reviewed. In particular, the staff plans to review calculations supporting the applicant's approach for the benchmark confirm behavior of the circular weld group.
