
Dear Material License Reviewer:




## Corporate Radiation Safety Officer Delegation of Authority



The management of Beaumont Health System grants the Corporate Radiation Safety Officer and the Radiation Safety Committee authority, organizational freedom, and management prerogative to:


- 1) Identify radiation safety problems;
- 2) Initiate, recommend, or provide corrective actions; and
- 3) Verify implementation of corrective actions.



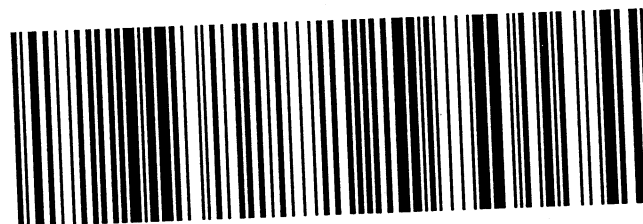
