On June 26, 2015, the U.S. Nuclear Regulatory Commission (NRC) completed a security baseline inspection at your Virgil C. Summer Nuclear Plant. The inspection covered one or more of the key attributes of the security cornerstone of the NRC's Reactor Oversight Process. The enclosed inspection report (IR) documents the inspection results that were discussed on July 7, 2015, with Mr. Gregg Douglass, yourself, and members of the Virgil C. Summer security staff.

No NRC-identified or self-revealing findings were identified during this inspection.
