On June 18, 2015, the U.S. Nuclear Regulatory Commission (NRC) completed a security baseline inspection at your McGuire Nuclear Plant. The inspection covered one or more of the key attributes of the security cornerstone of the NRC's Reactor Oversight Process. The enclosed inspection report (IR) documents the inspection results that were discussed on July 6, 2015, with you, Mr. Steven Capps, and members of the security staff.

No NRC-identified or self-revealing findings were identified during this inspection.
