Mr. Guill,

During a periodic licensing call on July 8 regarding R2.1 Seismic Hazard Reevaluation, you informed me that Duke Energy does not foresee meeting the 50.54(f) response date as required by letter dated May 9, 2015 (ADAMS Accession No. ML14111A147) for Oconee Nuclear Station, Units 1, 2, and 3, or H.B. Robinson Nuclear Plant to provide a seismic risk evaluation by June 30, 2017. Licensees are expected to meet current 10 CFR 50.54(f) submittal schedules unless the agency is notified by formal letters of known delays or extension requests and after the agency approves such an extension. Please advise if you plan to provide a formal letter in the near-term regarding current seismic risk evaluation development efforts and plans, specifically any anticipated deviations from current established schedules. Note this mail will be placed into ADAMS as an agency record.
