INSTRUCTIONS TO STUDENTS

ACCEPTANCE: This is to advise you that those individuals in Enclosure 1 have been accepted for participation in the training course (H-305) Safety Aspects of Industrial Radiography. This course is scheduled to be presented November 2-6, 2015, at Source Production and Equipment Company (SPEC), 113 Teal Street, St. Rose, Louisiana. SPEC is located in the James Business Park, a couple of miles west of the airport off of US Highway 61. The telephone number for the training site is (504) 464-9471. If you are unable to attend this course, please contact Marcia Casby immediately.

COURSE: The course starts at 8:00 a.m. on Monday, November 2 and ends at 1:00 p.m. on Friday, November 6. Students should bring dosimetry (dosimetry will be available for those who do not have issued dosimeters) and a scientific calculator. Students may dress casually and wear comfortable pants/slacks and shirts that will facilitate laboratory exercises.

LODGING AND TRAVEL: Please plan to arrive on Sunday, November 2, 2015, and depart on Friday, November 6, 2015. Students must make their own lodging and travel arrangements. If traveling by air, please contact El Sol Travel at 844-244-6694 no earlier than September 7, and no later than September 11 for airline reservations and indicate that the travel is "Invitational" for the NRC. Please select a fully refundable Government fare if one is available, and make sure that El Sol Travel correctly direct bills your fare to credit card ending 2835. Flights may be converted to less costly, non-refundable tickets, so please select carefully. If the need arises and you must make a change, please contact Marcia Casby at (301) 415-6525.

Please complete the Travel Application Form which will be provided to you and submit to Marcia Casby, ASTrainingandtravel.Resource@nrc.gov, at your earliest opportunity, but no later than September 11. Individuals should request the Federal government rate at the hotels. The per diem for St. Rose, Louisiana is \$89 hotel and \$51 meals and incidentals. The following hotel is located within a short distance from the training site. Please request the complimentary shuttle service which is available between the airport and the hotel, as well as the training center. Please contact the front desk for details upon arrival. Those students who elect to stay at an alternate hotel will be responsible for their own transportation. If you plan to drive, the Federal mileage reimbursement is 57.5 cents per mile. Rental cars are not authorized for travel.
