Dear Mr. Prussman:

By letter dated June 1, 2015, Entergy Nuclear Operations, Inc. submitted relief request IP2-ISI-RR-18 for Indian Point Nuclear Generating Unit No. 2. The relief request would use the 2001 Edition/2003 Addenda of ASME Section XI for the performance of inservice inspection (ISI) related activities associated with repair/replacements, pressure testing, and nondestructive testing during the Fifth 10-year ISI Interval.

The purpose of this e-mail is to provide the results of the Nuclear Regulatory Commission (NRC) staff's acceptance review of this relief request. The acceptance review was performed to determine if there is sufficient technical information in scope and depth to allow the NRC staff to complete its detailed technical review. The acceptance review is also intended to identify whether the application has any readily apparent information insufficiencies in its characterization of the regulatory requirements or the licensing basis of the plant.

The NRC staff has reviewed your application and concludes that it provides technical information in sufficient detail to enable the NRC staff to complete its detailed technical review and make an independent assessment regarding the acceptability of the proposed request in terms of regulatory requirements and the protection of public health and safety and the environment. Given the lesser scope and depth of the acceptance review as compared to the detailed technical review, there may be instances in which issues that impact the NRC staff's ability to complete the detailed technical review are identified despite completion of an adequate acceptance review. If additional information is needed, you will be advised by separate correspondence.
