Dear Mr. Tarver,

On behalf of the U.S. Nuclear Regulatory Commission (NRC), I am responding to your letter dated, May 28, 2015, in which you appealed the agency's May 19, 2015, decision related to your April 19, 2015, Freedom of Information Act/Privacy Act (FOIA/PA) request (FOIA/PA 2015-00248). In the May 28, 2015, letter you appealed the administrative closure of your request for your failure to respond to the May 5, 2015 fee estimate sent to you within 10 business days.

NRC Regulations require that the requester respond within 10 working days to NRC's notice that fees will be assessed. In the case at hand, a statement that you were willing to pay the estimated fee, (or a reduction in the scope of the request), was required before the NRC could continue processing the request<sup>1</sup>.

Additionally, in examining the letter that you submitted, dated May 19, 2015, and received by the NRC on June 1, you still had not submitted a willingness to pay, but rather asked if "more records can be released without doing any more search time." As such, even were the NRC to consider the letter you submitted, you still have not satisfied the requirements in responding to the fee estimate by indicating a willingness to pay, and your request was properly closed administratively.

This is NRC's final decision. As set forth in the FOIA (5 U.S.C. 552(a)(4)(B)), judicial review of this decision is available in a district court in the United States in the district in which you reside or have your principal place of business. Judicial review can also be had in the district in which the agency's records are situated or in the District of Columbia.

The 2007 FOIA amendments created the Office of Government Information Services (OGIS) to offer mediation services to resolve disputes between FOIA requesters and Federal agencies as a non-exclusive alternative to litigation. Using OGIS services does not affect your right to pursue litigation.
