This refers to your June 22, 2015 letter in response to the NRC letter dated April 29, 2015, regarding submittal of final written documentation of completion of the merger between AECOM Technology Corporation and URS Corporation, and the letter dated April 21, 2015, from John Volk, AECOM, regarding company name and Radiation Safety Officer (RSO) changes. As noted in our April 29, 2015 letter, an administrative amendment to your NRC license is necessary to reflect the transaction and name change. Enclosed with this letter is the amended license which includes the RSO change.
