The purpose of this modification is to provide incremental funding in the amount of \$138,278.00, thus increasing the total obligated amount from \$108,770.00 to \$247,048.00.

Accordingly, paragraph (d) of Section B.2 "Consideration and Obligation" is deleted in its entirety and replaced with the following:

"(d) the total amount obligated with respect to this contract is \$247,048.00, of which \$237,048.00 represents the incrementally funded amount for costs associated with paragraph (b) of this section and of which \$10,000.00 represents the incrementally funded amount for costs associated with paragraph (c).
