SUBJECT: NRC INSPECTION REPORT NO. 03037778/2015002; CONCRETE IMAGING, INC., CHARLES TOWN, WEST VIRGINIA SITE, TEMPORARY JOBSITE IN WASHINGTON, D.C., AND NOTICE OF VIOLATION

Dear Mr. Fravel:

On May 11 - 12, and June 2, 2015, and continuing in-office until July 27, 2015, Scott Wilson of this office conducted a security inspection at 240 John Rissler Road, Charles Town, West Virginia and at a temporary jobsite located in Washington, D.C., of activities authorized by the above listed NRC license. The inspection was an examination of your licensed activities as they relate to security and to compliance with the Commission's regulations and the license conditions. The inspection consisted of observations by the inspector, interviews with personnel, and a selective examination of representative records. The findings of the inspection were discussed with you via telephone at the conclusion of the inspection on July 27, 2015.

Based on the results of this inspection, the NRC determined that one Severity Level IV violation of NRC requirements occurred. Because of the security-related nature of the violation, a description of the violation and your corrective actions are included in non-public enclosures to this letter. The violation was evaluated in accordance with the NRC Enforcement Policy. The current Enforcement Policy is included on the NRC's website at <http://www.nrc.gov/about-nrc/regulatory/enforcement/enforce-pol.html>.

The violation is cited in the Notice of Violation (Notice), provided as Enclosure 1 to this letter. The violation was cited because the violation as identified by NRC. Enclosure 2 provides a determination of severity level and a description of the corrective actions taken by Concrete Imaging, Inc., to address the violation.
