Pursuant to requirements of 35.14(b), we hereby notify the Commission of the resignation of our Radiation Safety Officer, Brian Oyadomari. We have recruited a permanent Radiation Safety Officer, Dale Schippers, whose anticipated start date is yet to be determined (tentatively scheduled for August 11, 2015). In the meantime, we are requesting the appointment of Blaine T. Ikeda as temporary Radiation Safety Officer for the above referenced licenses, until Dale Schippers's employment has commenced.
