SUBJECT: SUMMARY OF A PUBLIC MEETING WITH SOUTHERN NUCLEAR
OPERATING COMPANY AND SOUTH CAROLINA ELECTRIC & GAS
ON MAY 14, 2015

The U.S. Nuclear Regulatory Commission (NRC) staff held a Category 2 public meeting with Southern Nuclear Operating Company (SNC) and South Carolina Electric & Gas (SCE&G) on May 14, 2015. The purpose of the meeting was to discuss issues associated with the safety review of licensing actions for SNC's Vogtle Electric Generating Plant (VEGP), Units 3 and 4, and SCE&G's Virgil C. Summer Nuclear Station (VCSNS), Units 2 and 3.

Summary of Meeting

On May 14, 2015, staff from the NRC conducted a public meeting with representatives from SNC and SCE&G to discuss issues associated with the safety review of licensing actions for SNC's VEGP, Units 3 and 4, and SCE&G's VCSNS, Units 2 and 3. Specifically, the meeting discussed a draft request for additional information (RAI) provided to SCE&G related to a request for a Commission-approved simulation facility.

As agreed by the staff and the licensee this topic is being discussed on a weekly basis. During the May 14, 2015, meeting the staff and licensee continued the discussion held on the May 7, 2015, meeting. Additionally, the staff discussed a draft RAI which was provided as a handout for the meeting. The licensee did not have any comments or questions regarding the draft RAI. In a letter dated June 25, 2015, SCE&G provided a response to the staff's RAI. The response can be found in ADAMS under package Accession Number ML15182A188.
