Dear Mr. Hsu:

By letter dated May 14, 2015, the U.S. Nuclear Regulatory Commission (NRC) staff provided its initial results of the acceptance review (Agencywide Documents Access and Management System (ADAMS) Accession No. ML15114A004) for the Doosan HF Controls (HFC) submissions provided for NRC staff review "Amendment for the Enhanced Equipment of HFC-6000 Safety Evaluation Report" (ADAMS Accession No. ML11297A041) and "Amendment for Fast Performance Controller Platform of HFC-6000 Safety Evaluation Report" (ADAMS Accession No. ML131420097).

HFC provided supplemental information in response to the questions provided in the May 14, 2015, NRC staff letter. This supplemental information was provided in letters dated June 15 and July 9, 2015 (ADAMS Accession Nos. ML15175A372 and ML15211A291).

We have found that the material presented is sufficient to begin our review.

The NRC staff expects to issue its request for additional information by March 25, 2016, and issue its draft safety evaluation (SE) by October 31, 2017. This schedule information takes into consideration the NRC's current review priorities and available technical resources and may be subject to change. If modifications to these dates are deemed necessary, we will provide appropriate updates to this information.

The NRC staff estimates that the review will require approximately 1200 hours, including project management and contractor support. This estimate of hours includes the hours already expended on completing this acceptance review. The review schedule milestones and estimated review costs were discussed and agreed upon in an August 10, 2015, email exchange with Mr. Ivan Chow representing HFC.
