Dear Mr. Freudenberger:

We reviewed your letter dated July 27, 2015, transmitting changes to Chapter 1, General Information, of your application for License SNM-124. We find the changes to be acceptable. Specifically, we made the following findings:

- The changes do not decrease the level of effectiveness of the design basis described in the license application.
- The changes do not depart from the evaluation methods described in the license application to establish the design basis.
- The changes do not result in a degradation of safety.
- The changes do not affect compliance with applicable regulatory requirements.
- The changes do not conflict with an existing license condition.

Therefore, we find that Nuclear Fuel Services was authorized to make the changes without prior U.S. Nuclear Regulatory Commission (NRC) approval pursuant to License Condition S-2.

This action was assigned Technical Assignment Control (TAC) Number L33380. TAC L33380 is considered **CLOSED**.
