

Dear Mr. Denton:

This letter is written to confirm conversations with members of your staff regarding a proposed facility operating license change transmitted by my letter dated July 5, 1978. The change related to the possible receipt of four fuel assemblies by Duke from Florida Power Corporation (Crystal River Unit 3, Docket No. 50-302). Florida Power has subsequently requested that Duke cease licensing activities in this regard.

We, therefore, request that the proposed amendment to both the license and the indemnity agreement (B-44) be withdrawn and further request that the balance of the license fee previously remitted in this matter be refunded to Duke.
