

Dear Sir:

Your letter of May 29, 1980 requested Duke Power Company to submit, pursuant to 10CFR Part 50.36(c)(5), an amendment to the Oconee Operating License to revise the required reporting requirements to those of Regulatory Guide 1.16, Revision 4. My letter of July 31, 1980 was provided in response to your request, and stated that the addition of Item 9 of Section C.2.a of this Regulatory Guide to the Oconee reporting requirements was not necessary. Furthermore, it was considered that the addition of this reporting requirement to the Oconee Technical Specifications would not improve safe operation of the facility, as identified in 10CFR 50.36(c)(5).

Nevertheless, attached is proposed Technical Specification 6.6.2.1.a(9) which is submitted per your request. This submittal is provided in response to an NRC request, and therefore, pursuant to 10CFR 170, §170.22, Note 2, no license fees are provided.




