
Dear Sir:

Pursuant to 10CFR 50, §50.90, the attached proposed amendment to the Oconee Nuclear Station Facility Operating License and revision to the Technical Specifications is submitted. This proposed change, which supplements my previous submittal dated November 30, 1976, revises parts of Specification 3.6, Reactor Building and Specification 4.4.1, Containment Leakage Tests to reflect the requirements of 10CFR 50, Appendix J.

Attachment 1 to this submittal provides the proposed revision pages to the Technical Specifications. Within proposed Table 4.4-1 Type C tests are not required for certain systems and reverse testing of certain containment isolation valves is noted. Attachment 2 details the test requirement bases for systems where Type C tests are not performed and also provides justification for reverse direction testing as noted as being needed by 10CFR 50, Appendix J, III.C.1.

Inasmuch as this request supplements an earlier request on this subject, it has been determined that no license fees are required.
