

Dear Mr. Denton:

By letter dated May 19, 1980, Duke requested that the NRC authorize disposal of quantities of contaminated oil by burning. In subsequent discussions with the staff, it has been determined that a license amendment revising Oconee Technical Specifications is required. The Staff has prepared the proposed change which has been discussed with Duke.

Because of this necessary licensing action, license fees are required. A check in the amount of \$4,000 was provided with the original submittal. Please find attached a check in the amount of \$800 to cover the remaining portion of the required fee.
