

By your letter dated May 25, 1983 to H. B. Tucker, the NRC Staff requested licensing fees for issuance of an amendment to the Facility Operating License for McGuire Unit 1, which concerns the addition of a license condition for verifying acceptability of Model D2 steam generator design modifications. Also, by letter dated June 15, 1983 to H. B. Tucker, your Staff requested licensing fees pertaining to our request for exemption to location requirements for the Emergency Operations Facility for Oconee Nuclear Station.
