
Subject: Oconee Nuclear Site

Administration and Control of Keowee Hydro Station

Oconee Nuclear Station was originally licensed by the NRC with the Keowee Hydro Station providing its source of emergency power. Keowee has historically provided outstanding service to Oconee in this role. The administration of functions at Keowee has been the responsibility of the Fossil/ Hydro Department of Duke Power Company.

A recent evaluation of Keowee's role as the emergency power supply to Oconee has led to a decision to realign the administration and control of Keowee to the Nuclear Generation Department. The Keowee Station and its operating staff will be under the direct management of the Oconee Site organization. The operation of Keowee will be directly controlled by the Oconee Operations group. Reporting responsibilities in the maintenance, engineering, and other areas will be determined after further evaluation.
