
Pursuant to 10CFR 50.55a, attached for your information is the latest IST Program Manual for Oconee Nuclear Station. A summary of the major changes is provided to assist in identifying the changes made which vary from revision 19 submitted to you on May 27, 1992.

On August 10, 1992 a revision to Relief Request # 4 concerning HP-101 and 102 was submitted to NRC. Although the attached IST Program Manual modified Relief Request # 4 from the August 10, 1992 submittal, the submittal describes our testing process during the Third Inspection Interval until December 1, 1992.

On August 5, 1992 a revision to Relief Request # 10 concerning CF-11 and 13 was submitted to the NRC. The attached IST Program Manual incorporates the revised Relief Request as submitted on August 5, 1992.
