Pursuant to 10CFR 50.55a, the latest IST Program Manual for Oconee Nuclear Station was submitted to the NRC on January 4, 1993. On July 23, 1993 NRC issued a Safety Evaluation Report detailing the results of the review of the submittal. The Safety Evaluation gave 90 days to be in compliance with ASME Section XI and Generic Letter 89-04 or provide additional information to support the denied relief request. Due to plant activities requiring the resources of key personnel involved in the IST Program, there was insufficient time to adequately determine necessary procedure or program changes to address the details outlined within the SER. Duke Power will be unable to provide the additional information within the 90 days specified in the Safety Evaluation Report. The additional information will be submitted by December 6, 1993.
