This letter refers to an investigation conducted by the U.S. Nuclear Regulatory Commission (NRC), Office of Investigations (OI) to determine if a QualTech NP employee willfully provided false information relative to Report EGS-TR-HC1741-01, "Test Report for LOCA/DBA Environmental Qualification Test of Firewall III, Insulated Wire/Cable Manufactured by RSCC Wire and Cable, LLC," dated June 28, 2013. NRC's investigation also examined the concern that an RSCC Wire and Cable official had a role in influencing the QualTech employee to provide the alleged false report. Based on the evidence developed during the OI investigation, the NRC could not substantiate that wrongdoing occurred.
