Dear Mr. Bergman:

By letter dated August 4, 2015 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML15218A219), Mr. Steve Mirsky, Manager, Licensing, requested that the following presentation slides be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390:

- NuScale Effluent Release (GALE Replacement) Methodology, PM-0715-16229-P, Revision 0, Proprietary Version ADAMS Accession No. ML15218A221

A non-proprietary copy of the presentation slides and the affidavit have been placed in the U.S. Nuclear Regulatory Commission (NRC) Public Document Room and added to ADAMS at the following accession number:

- NuScale Effluent Release (GALE Replacement) Methodology, PM-0715-16229-NP, Revision 0, Non-proprietary Version ADAMS Accession No. ML15218A220

The affidavit in the August 4, 2015, letter stated that the submitted information should be considered exempt from mandatory public disclosure due to the proprietary nature of the information that will be presented and discussed.

The NRC staff has reviewed your application and the material in accordance with the requirements of 10 CFR 2.390 and, on the basis of the statements in the affidavit, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure. Therefore, the version of the submitted information marked as proprietary will be withheld from public disclosure pursuant to 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.

Withholding from public inspection shall not affect the right, if any, of persons properly and directly concerned to inspect the documents. If the need arises, the NRC staff may send copies of this information to our consultants working in this area. The NRC staff will, of course, ensure that the consultants have signed the appropriate agreements for handling proprietary information.
