Dear Mr. Stewart:

Enclosed is Amendment No. 60 to your NRC Material License No.13-02128-03 in accordance with your request. Please note that the changes made to your license are printed in **bold** font.

We made some minor updating and formatting changes to your license, which are also shown in **bold** font.

Condition No. 14 of your license has been amended to accommodate use of your HDR device in its current room or in the newly approved room, when you have it installed there.

After you move the device into the new room, you must submit the final leak test on the HDR source taken prior to the move to the new room.

Your submission should be in the form of the usual amendment request style. If the last leak test on the HDR source taken prior to the move is the one that the vendor took when shipping it to you, and if that is within the six month interval between required leak tests, then you won't have to repeat the test. Just submit that leak test result to demonstrate no residual contamination remained.

This will support the amendment request you should then make to remove the old room from your license at that time, which is the correct procedure to follow.

When submitting your response to the above, please mark it as "additional information to control number 588413" to my attention. This will help ensure that it is handled appropriately in our offices. Only one complete, currently dated and signed response is needed.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you.

This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions.

Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture.
