Dear Sir/Madam:

I am conducting research on the construction of three nuclear power-generating units in Upstate New York during the 1960's and 1970's. These facilities are the Nine Mile Point Nuclear Generating Station, Units 1 and 2, and the James A. Fitzpatrick Nuclear Generating Station, all located in the town of Scriba, NY. It is my understanding that construction on these units (all of which are located on the same physical property) began in the mid-1960's and ended in the late 1970's. In connection with my research I request that you search your records (or allow me to search your records) for the following materials relating to the construction of these three facilities – all of these documents relate to the facilities' records of construction (i.e. what was occurring where and when during the construction):

- Contract status statements for the various contracts involved in constructing these units, in particular any contract status reports between the site owners (be they Niagara Mohawk Power Corporation or the Power Authority of the State of New York) and construction manager Stone & Webster Engineering Co., insulation contractor Robert A. Keasbey Co., nuclear reactor and steam turbine manufacturer/installer General Electric Company, powerhouse piping contractor M.W. Kellogg Co., HVAC and Reactor/Waste disposal duct work contractor J&K Boiler Co., and aluminum and condensate manufacturer/installer Pittsburgh-Des Moines Steel Co.;
- Field office reports concerning the construction/status of construction generated by the site owners (i.e. Niagara Mohawk Power Corporation
