Can you pass on this e-mail or give me a POC?

I was just told that Smiths Detection (manufacturer) that they were only able to confirm that the M22 ACADA was manufactured in 2001 (based on the PCBA Lot no. GYI01K009-53), but were unable to provide any further details on the item because it pre-dates their PDA system in Manufacturing, that would otherwise have provided a computer-searchable system for identifying the item's final serial number.

Given the above, the Army will not be able to know who it belonged to, whether it was under the Army NRC License 21-32838-01 Amendment 7, and whether it had radioactive sources when it was retrieved from E-Bay.
