INSTRUCTIONS TO STUDENTS

ACCEPTANCE: Individuals listed in Enclosure 1 have been accepted for participation in the Health Physics for Uranium Recover (F-104) course. This course is scheduled to be presented October 26-30, 2015, at the Moab Valley Inn at 711 South Main Street, Moab, Utah. Please contact Marcia Casby at 301-415-6525 immediately if you are unable to attend this course.

COURSE: Please see our website, <https://scp.nrc.gov/training.html> for the Tentative Course Schedule and note that the course begins at 8:00 a.m. on Monday, October 26 and ends at noon on Friday, October 30.

LODGING AND TRAVEL: Please plan to arrive on Sunday, October 25, 2015, and depart on Friday, October 30, 2015. Students must make their own lodging and travel arrangements. If traveling by air, please contact El Sol Travel at 844-244-6694 no earlier than September 7, and no later than September 11 for airline reservations and indicate that the travel is "Invitational" for the NRC. Please select a fully refundable government fare if one is available, and make sure that El Sol Travel correctly direct bills your fare to credit card ending 2835. The closest major airport is the Salt Lake City International airport which is approximately 3 1/2 hours from the training site. Attendees must arrange for a rental vehicle which must be approved by the State. NRC will not provide reimbursement for rental cars. Please note that transportation to the site tours will be provided. Flights may be converted to less costly, non-refundable tickets, so please select carefully. If the need arises and you must make a change, please contact Marcia Casby at 301-415-6525.

Please complete the Travel Application Form which will be provided to you and submit to Marcia Casby, ASTrainingandtravel.Resource@nrc.gov, no later than Friday, September 11. Individuals should request the Federal government rate at the hotels. The per diem for Moab, Utah is \$130 hotel and \$56 meals and incidentals. If you are authorized to drive, the Federal mileage reimbursement is 57.5 cents per mile. Note that a block of rooms has been set aside for you at the \$100 group rate.
