The NRC Staff ("Staff") is correcting an error in its submission of a hearing exhibit pre-filed on August 10, 2015. Consistent with the description of NRC Staff Exhibit ("Ex.") NRC000188 in Staff's exhibit list and in the "NRC Staff Testimony of Dr. Allen Hiser, Dr. Ching Ng, Mr. Gary Stevens, P.E., and Mr. On Yee, Concerning Contentions NYS-26B/RK-TC-1B and NYS-38/RK-TC-5" (Ex. NRC000168), at page 78, Ex. NRC000188 was intended to be Entergy Letter NL-15-060 (May 12, 2015).
