I have reviewed the updated changes to License Condition 20-1 and believe the extensive damage management guidelines (EDMGs) should be removed from the listed parenthetical procedures/guidelines in the revised item b. The Loss of Large Area Mitigative Strategies Description (LOLA MSD) contained in the LNP COLA addresses the strategies that must be in the EDMGs. The title of this License Condition is “Mitigation Strategies for Beyond Design Basis External Events” which LOLA is not (LOLA is not an external event). I have provided a markup of my suggested changes below.

The overall integrated plan required by this condition must include guidance and strategies to maintain or restore core cooling, containment, and spent fuel pool cooling capabilities. The overall integrated plan must include provisions to address all accident mitigation procedures and guidelines (including the guidance and strategies required by this section, emergency operating procedures, ~~and abnormal operating procedures, and extensive damage management guidelines~~).
