The requested information is provided in the Enclosures to this letter. Enclosures 1, 3, and 4 provide Safeguards Information and should be withheld from public disclosure. Enclosure 2 provides Security Related Information and should be withheld from public disclosure under 10 CFR 2.390. Enclosures 5 and 6, when taken together, provide Safeguards Information and should be withheld from public disclosure, but upon separation from each other provide Security-Related information and should be withheld from public disclosure under 10 CFR 2.390.
