By letter dated September 29, 2014 (Letter L-14-321, Accession No. ML14275A039), the FirstEnergy Nuclear Operating Company (FENOC) submitted Revisions 17 and 18 of the "Physical Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan" in accordance with Title 10 of the *Code of Federal Regulations*, Section 50.54(p)(2) for the Davis-Besse Nuclear Power Station, Unit No. 1.

On July 8, 2015, the Nuclear Regulatory Commission (NRC) staff requested additional information regarding this plan (Accession No. ML15163A221). FENOC's response to the request is attached. The attachment contains Safeguards Information and pursuant to 10 CFR 73.21, is to be withheld from public disclosure.

A conference call between FENOC and NRC personnel was held on August 5, 2015, to clarify the information requested. As part of this conference call, it was agreed that the response would be submitted on or before August 17, 2015, to incorporate the information discussed during the conference call.


