The following additional information is needed to complete the review of your request to terminate your NRC license.

1. Please submit a list the radionuclides that were actually used or stored at your facility. Your NRC license authorized 9 Troxler model gauges, three radionuclides, with multiple millicurie amounts for numerous gauges. For example, Troxler model 3241-C with authorization for three sealed americium-241 sources, one 100 millicurie source and two 300 millicurie sources. Also Troxler models 3430, 3440, 3450, 3430-M, and 3440-M, with authorization for sealed cesium-137 sources, sealed americium-241 sources, and sealed californium-252 sources. Again, please submit a list of the radionuclides that were actually used and stored at your facility. For example, if you only had one Troxler model 3241-C gauge containing a 100 millicurie americium-241 sealed source, please state so. If you did not have any of the other gauges or radionuclides that were authorized on your NRC license, please state that you never received or possessed any other gauges (such as the Troxler model 3430, 3440, 3450, 3430-M, or 3440-M) or radionuclides (such as cesium-137 or californium-252).
2. Please specify the date when the gauges(s) and radionuclide(s) were transferred to Bucyrus Road Materials, Inc.
3. Please submit a copy of the leak test(s) for the radionuclide(s) that were current when the gauge(s) were transferred to Bucyrus Road Materials, Inc.
4. Please confirm that all gauge(s) and radionuclide(s) have been removed from your facility and transferred to Bucyrus Road Materials.
5. Please submit a copy of the acknowledgement letter from Bucyrus Road Materials that they received the radioactive materials were transferred from O'Banion Laboratories Corporation.

Please include a cover letter on company letterhead, dated and signed (signed by an individual who is authorized to sign official documents on behalf of the licensee) with your response letter.
