In accordance with 10 CFR 71.95, "Reports," sub-paragraph (a)(3), Exelon Generation Company, LLC (EGC) is submitting this report to communicate potential instances in which the conditions of approval in Certificate of Compliance (CoC) No. 9168 for the EnergySolutions LLC 8-120B transport package [USA/9168/B(U)-96] may not have been followed for shipments of radioactive material from EGC nuclear stations.

The 8-120B condition prompting this report was initially communicated to the NRC by EnergySolutions LLC in the referenced letter. This report is based on EGC's discovery of the condition on June 24, 2015 when EnergySolutions LLC provided the referenced letter to registered users of the 8-120B. This notification is required to be submitted within 60 days. Accordingly, this submittal is due by August 24, 2015.

The condition involves a potential reduction in test sensitivity for a neoprene gasket that is installed in 8-120B test manifolds. This potential reduction in test sensitivity would have affected 8-120B shipments from September 2013 through June 2015. EnergySolutions LLC discovered the potential reduction in sensitivity after validating a concern that was originally communicated to EnergySolutions LLC by a cask user on June 1, 2015. As described in the referenced letter, the engineering evaluation concluded that there were no safety significant issues associated with the condition.

The attachment to this letter provides a list of instances where EGC used the 8-120B transport package from September 2013 through June 2015 to ship radioactive material from the EGC nuclear stations.

There are no regulatory commitments in this submittal.
