Supplement 1: Response to Generic Letter 95-07, Pressure Locking and
Thermal Binding of Safety-Related Power-Operated Gate Valves

Gentlemen:

On October 16, 1995, Duke Power Company submitted the required 60-day response to Generic Letter (GL) 95-07 informing the NRC of Duke's intentions regarding the requested actions. Duke stated it intended to waive the 90-day requested actions and to focus on compliance with the 180-day requested actions. In a letter, dated November 3, 1995, the NRC reiterated the need for Duke Power Company to commit to the 90-day requested actions of GL 95-07 or provide the safety basis for determining the acceptability of the planned alternative course of action by November 15, 1995.

Subsequently, in view of the guidelines provided at the November 2, 1995, NRC Region 2 Workshop which more specifically defined the intent of the 90-day requested actions, Duke Power Company was able to comply with the 90-day requested actions by conducting an initial assessment, using current knowledge, of all safety-related power operated gate valves.
