Summary of ECCW System Upgrade

On November 1, 1995, Duke Power met with the NRC to provide updated information on planned modifications to the Oconee Nuclear Station (ONS) Emergency Condenser Circulating Water (ECCW) System. In this meeting, Duke management proposed to submit a letter containing a detailed description of the ECCW System upgrade by December 31, 1995. The purpose of this letter is to assist in closure of several outstanding ONS service water system open items. The attached report includes background information followed by a detailed description of the ECCW System upgrade. The detailed description of the ECCW System upgrade includes all relevant information on application of design criteria, quality assurance program requirements, operational considerations, and testing requirements in order to clarify the ONS ECCW System licensing basis.

As agreed upon in the November 1, 1995, meeting, Duke requests a reply to this submittal by April 1, 1996, to facilitate completion of the ECCW System upgrade.
