Generic Letter 94-04: Voluntary Reporting of
Additional Occupational Radiation Exposure Data

By letter dated January 20, 1995, Duke Power informed the NRC of its intent to voluntarily provide the information requested in Generic Letter 94-04. The original commitment was to provide the requested historical exposure information within 18 months or by March 2, 1996. However, due to the magnitude of the information requested and the manual effort involved in completing the task with existing resources, this date cannot be met. Duke Power is still committed to supplying the requested exposure data in support of the voluntary NRC request. In order to realistically complete the request in its entirety, we request a three(3)year commitment extension per the following schedule:

Catawba Nuclear Station's data submitted by 3/2/97
McGuire Nuclear Station's data submitted by 3/2/98
Oconee Nuclear Station's data submitted by 3/2/99

Note that all data for Duke Power's Corporate Office employees (approximately 2,000 reports) have already been completed.


