Supplement to Amendment 21

Pursuant to 10 CFR 50.54(a)(3), Amendment 21 to the Duke Power Company Topical Report *Duke-1-A, Quality Assurance Program* (Topical Report) was submitted by letter dated July 11, 1996. Duke Power is requesting that supplementary information be added to Amendment 21, which is presently undergoing NRC review.

Topical Report pages 17-15 and 17-21 (which is Figure 17-3) are included in this supplement and are shown in marked format in Attachment 1 of this letter. The new proposed pages are shown in Attachment 2 of this letter.

This supplement to Amendment 21 describes changes that were recently made to the Duke Nuclear General Office (NGO) organization. In accordance with the existing requirements of Section 17 of the Topical Report, Duke is hereby advising the NRC of these organizational changes.

The NGO reorganization, which became effective October 23, 1996, eliminated the Engineering Support Division (ESD) and transferred the affected work functions to other existing divisions within the NGO organization. The Procurement Engineering and Supplier

Verification Sections of the former ESD have been relocated to the Station Support Division. The maintenance and engineering functions (Mechanical Equipment and Valves, Mechanical Systems, Civil/Structural, and Electrical Systems and Equipment Sections) of the former ESD have been relocated to the Nuclear Engineering Division.

Additionally, the Operational Aid Computer Project was moved organizationally from the former ESD to the Electric System Support Department, but this change does not impact the Topical Report. The new NGO organization is described, and shown figuratively, in the pages included in this supplement to Amendment 21.

Duke believes the organizational changes described in this supplement to the proposed Amendment 21 of the Topical Report are administrative in nature and do not reduce any current quality related commitments. It is requested that this supplement be added to the contents of the July 11 submittal and that the NRC complete its review of Amendment 21 in a timely manner.
