
Volume C Revision 97-02, February, 1997

This revision is being submitted in accordance with 10 CFR 50-54(q) and does not decrease the effectiveness of the Emergency Plan or the Emergency Plan Implementing Procedures.

The "Oconee Nuclear Site Emergency Telephone Directory" is being removed from Volume C of the Emergency Plan Implementing Procedures. This directory is not an implementing procedure but was contained in Volume C for convenience. Because of recent policy changes from the NRC concerning privacy information described in CFR 2.790, the decision was made to remove the directory from Volume C and designate it as a controlled document. The directory will be updated quarterly and distributed to the areas and groups necessary. Locating and controlling the directory as explained will negate the need to request its withholding from public disclosure. This will result in less administrative cost for Duke Power Company and the NRC. Restricting facility and position phone numbers from public distribution will be beneficial to all parties during drill and actual events. By copy of this letter, two copies of this revision are being provided to the NRC Region II, Atlanta, Georgia.

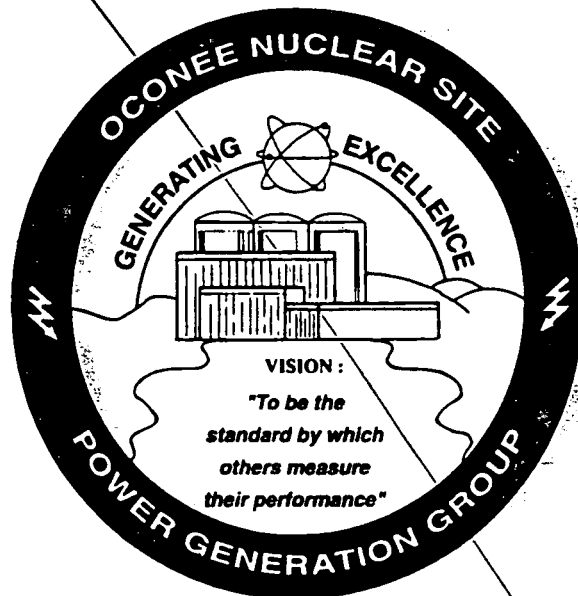
