

The purpose of this letter is to seek clarification of regulatory requirements for post certification frequency and procedure contained in 10 CFR 73, Appendix B.

10 CFR 73 Appendix B, Criterion II.B contains qualification requirements. Criterion II.E states that requalification shall be at least every twelve months and shall be in accordance with the NRC approved licensee training and qualification plan. Duke considers that following initial training and post certification, as long as an officer works the majority of the posts on a regular basis, a formal scheduled annual recertification is not required. If an officer is assigned a post that the officer has not worked for a period of time, then the officer will read the relevant post procedure and discuss questions with the immediate supervisor.

Staff concurrence in the above is requested as promptly as possible.
