On August 18 and 19, 1982 a meeting was held between representatives of Duke Power Company (DPC), the Nuclear Regulatory Commission, and Franklin Research Center to discuss the Oconee Nuclear Station (ONS) Radiological Effluent Technical Specifications (RETS). At the conclusion of that meeting, DPC agreed to submit a revised RETS application which would incorporate all of the agreements reached during that meeting by November 15, 1982.

The proposed changes are currently under review to assure that the changes are technically correct and can be properly implemented promptly upon NRC approval. As such, the revised RETS application will be submitted by December 15, 1982.
