By letter of November 10, 1982, we stated that the revised Oconee Nuclear Station Radiological Effluent Technical Specifications (RETS), that would incorporate all of the agreements reached during the August 18 and 19, 1982 meeting, would be submitted to you by December 15, 1982.

To ensure that these changes can be properly implemented, and the design features to meet them will be completed by the approved time of applicability, the RETS submittal must continue to be reviewed internally.
