

Your letter of June 2, 1980 requested that the RETS for the Oconee Nuclear Station be revised according to comments provided by the Staff's review of it and be resubmitted within 90 days. The revised Offsite Dose Calculation Manual and proposed process control program for the solid waste system were to be provided with this submittal. However, preparation and review of the requested documentation has not been completed by Duke Power Company. It is expected that this work will be completed by September 30, 1980, at which time it will be submitted to you.
