Pursuant to Oconee Nuclear Station Technical Specification 6.6.1.4 and 10 CFR 50.36a (a)(2), please find attached the 1985 Radioactive Effluent Release Report for July 1 - December 31, 1985.

Attachment 1 contains the second Semi-Annual Radioactive Effluent Release and Solid Waste Disposal Report. Attachment 2 provides details of unplanned (or abnormal) offsite releases which are summarized on the second page of Attachment 1. The meteorological data, concurrent with the release of gaseous effluents, is included as Attachment 3. Pursuant to Technical Specification 3.5.5, please find attached (Attachment 4) a description of all Radioactive Gas and Liquid Monitors that were inoperable for greater than 30 days.
