Mr. William P. Gammill's letter of October 2, 1979, described briefly a course in radiation safety given by Oak Ridge Associated Universities to members of the NRC staff who may visit licensed facilities. This letter requested that Duke Power Company accept certification of completion of this course in lieu of each NRC staff member having to undergo basic radiation training at each facility.

We have reviewed this proposal and find it to be acceptable. As noted in your letter, NRC staff members will still have to undergo site-specific Health Physics, emergency response and security indoctrination training.
