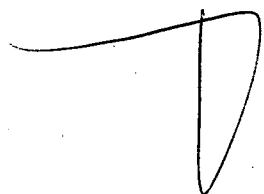

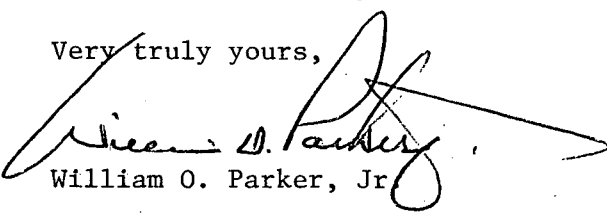

In a letter dated August 21, 1979, the Staff requested that a detailed analysis of the thermal-mechanical conditions of the reactor vessel during recovery from small breaks with extended loss of all feedwater be performed. My letters of December 21, 1979 and February 15, 1980 addressed delays in providing this analysis.

This effort has been further delayed and is currently expected to be provided in late June 1980. Consequently, following our formal review, the report will be submitted by July 15, 1980.
